Dear Parent/Guardian:

As a District, we are committed to being proactive in doing everything possible to protect our students and staff. Over the years, experience tells us that students rely on and find comfort in adults who can protect them during emergencies. Therefore, we focus on prevention, preparedness, responding, and recovery as necessary key elements for crisis planning. Safety has evolved into being a multifaceted District initiative involving continuous communication and effective partnerships with law enforcement, administration, staff, students, and parents.

As per State Law P.L. 2017 c.162 every Superintendent is required to designate an administrator as their School Safety Specialist. As the District's designee, I was trained for this position by the NJ DOE Office of School Preparedness and Emergency, as well as, participating in multiple security workshops and seminars. My responsibilities include supervising and providing necessary training and oversight for all school safety while serving as a liaison to national, state, and community agencies. These recommended Best Practices have been integrated into our schools' security procedures and protocols to strengthen our security. Additionally, below you will find a synopsis of some of our existing safeguards.

We have a comprehensive School Safety and Security Plan in place and rigorously train staff to handle various emergency situations. On November 1, 2010, as per N.J.S. 18A: 41-1, every school is required to conduct one fire drill and one security drill each month within the school hours including any summer months during which school is open for instructional programs. Students and staff practice and experience what is expected of them during these security drills. Law Enforcement always plays an integral part in our drills and in keeping our students safe. During the academic year, schools are required to:

- conduct a minimum of two of the following Security Drills: Active Shooter; Bomb Threat; Evacuation; and Lockdown
- other types of Security Drills practiced are Shelter in Place; Testing of the Schools Notification System and Procedures; Tabletop Exercise; and Reverse Evacuations
- perform two School Bus Emergency Evacuation Drills as per New Jersey Administrative Code (NJAC 6A:27-11.2)
- all Fire, Security and Bus Evacuation Drills outcomes are reported to the County and certified by our Superintendent, Dr. Howard Lerner

Our current Memorandum of Agreement between the District and law enforcement ensures a cooperative and positive working relationship. We maintain a strong partnership with the Bergen County Prosecutor's Office, Sheriff's Office, County Fire Marshall, Office of Emergency Management (OEM), EMS, and Bergen County Association of School Security Professionals. Together we have collaborated on the

following:

- updating security procedures for drilling and responding to emergency situations including Evacuation/Reunification Plans
- facilitating District Safety/Security Meetings with campus administration, the Adult Programs, Sheriff's Office and School Resource Officers, Day Care Center - BELA, Operations, OEM, Technology, and Transportation
- training for administration, faculty, bus drivers, and maintenance/custodial staff on Stop the Bleed with EMS
- updating Visitors' Policy and use of campus internal and external digital cameras
- recognizing and addressing the social and emotional needs of students through a variety of programs

COVID-19 has added another layer to school safety and security, with a focus on physical and emotional health and well-being. With the guidance of the State and County health officials, we have created the [Bergen County Technical Schools Restart Plan](#), which outlines the health and safety protocols for the opening of the 2021-2022 school year. Compliance with these protocols will keep everyone in our community safe, so parents/guardians are encouraged to review this plan and any updates broadcast by their child's respective schools. To re-engage students, help them rebuild relationships, and offer social-emotional support, we will continue to follow our long-established procedures for working with students in need of individualized mental health interventions. In partnership with Bergen County Therapy, the Navigating Success Through Wellness program offered various student support groups over the summer and also completed intakes for our incoming 9th grade students. Throughout our reopening, we will connect families and students to wraparound services and resources as needed.

As parents, you play an essential role in promoting school safety by following procedures. We realize open communication is critical for the safety and well-being of our community. Should there be an emergency situation, the District will immediately notify you through text, email and phone. Therefore, make sure your contact information is always updated and accurate in your children's school.

Be assured that the safety of your children continues to be our priority. We want them to feel safe, respected, trusted and connected to their school community. In this day and age, we all play a vital role in school safety. We encourage you to talk to your children about safety/security issues at home and in school. Please reinforce to your children the importance of "*if they see or hear something, they need to say something*" to a parent/guardian, administrator, or school staff.
